



TRANSPORTED SEMEN AGREEMENT INSTRUCTIONS

1. Please complete and sign the Transported Semen Agreement and **mail or fax the completed Transported Semen Agreement, a copy of your Breeding Contract and a copy of the mare's registration certificate** to Boechat Equine
2. The Collection/Shipment fee (\$300) for cooled semen and the Refundable Equitainer Deposit (\$250) are due to Boechat Equine before the first shipment. For frozen semen special arrangements need to be made. Checks, Cash or Visa and MasterCard credit cards are accepted for payment. Please complete the credit card authorization at the bottom of these instructions if you wish to pay by this method. A fee of \$40.00 will be charged for returned checks.
3. ***NO SEMEN WILL BE SHIPPED UNLESS THE ABOVE FEES HAVE BEEN PAID AND AGREEMENTS HAVE BEEN SIGNED AND RETURNED.***
4. Mare owners must notify Boechat Equine. when their mare comes into the heat cycle in which they intend to breed.
5. A minimum of 24 hour notice is needed prior to shipment of semen and orders **must** be placed by **10:00 AM Central Standard Time.**
6. Collection days are Mondays, Wednesdays and Fridays. Delivery will be on Tuesdays, Thursdays and Saturdays. With exception for the Stallions that will be showing in 2010.
7. Please notify Boechat Equine at (405) 802-1710 when you wish to receive your shipment of semen. Provide the complete address where the semen is to be shipped and the name and registration number of the mare being inseminated. Remember, **24 hour notification is necessary.** Semen will be shipped Federal Express Priority Overnight and you will receive it on Tuesday, Thursday, or Saturday.
8. Return the Equitainer and its contents **within 3 days** to:

Should the client not return the Equitainer to Boechat Equine within three working days from the client's receipt of said Equitainer, the client's account will be charged \$25.00 per day late fee. Should the Equitainer not be returned to Boechat Equine within a two week period, the client's account will be charged \$500.00.

9. ***BOECHAT EQUINE MUST BE NOTIFIED WHEN YOUR MARE IS CHECKED IN FOAL. MARE OWNER MUST AGREE TO HAVE THE MARE EXAMINED FOR PREGNANCY AND TO NOTIFY BOECHAT PERFORMANCE HORSES, LLC. OF THE RESULTS WITHIN TEN (10) DAYS OF THE 60-DAY PREGNANCY CHECK.***
10. The breeding season starts February 1, 2010 and terminates on July 31, 2010.
